Statement of non-governmental organizations to the Advisor to the Prime Minister of Georgia on Human Rights, Mr. Niko Tatulashvili

Mr. Niko,

With this letter, non-governmental organizations operating in Georgia (see the list below) are addressing you in order to once again openly state our position regarding the draft law initiated by members of the parliamentary majority on the transparency of foreign influence¹ and to present our opinion regarding our involvement in the process of developing the human rights action plan.

Signatory organizations that have been fighting for years, using various formats, to protect children and women who are victims of violence, religious and ethnic minorities, persons with disabilities, victims of torture and inhuman and degrading treatment, LGBTQI people, illegally detained, displaced, homeless people, prisoners, socially vulnerable families, illegally dismissed citizens; organizations that have been working for years to implement better institutional arrangements and reforms consistent with the principle of a democratic state, consider it important to have a coordinated and effective participation in the process of developing a human rights action plan.

For this purpose, after February 28 was set as the deadline for submission of written opinions on the human rights protection action plan by non-governmental organizations at the February 3, 2023 meeting, two coordinated gatherings were held between representatives of non-governmental organizations.

Regarding the action plan for the protection of human rights, non-governmental organizations were ready to present written opinions in a coordinated manner, but we believe that the initiation of the draft law on the transparency of "foreign influence", taking into account the already existing Russian experience of increasing control, harassment and repression, is directly related to and makes impossible the goals set by the strategy and effective execution of any tasks/activities to be considered in the action plan.

We believe that the adoption of this draft law undermines constitutional principles and, as a result, the idea of establishing a democratic, social state of rule of law, protection of constitutional and convention rights is endangered. Adoption of the draft law will radically worsen the legal environment in the state, damage the process of the country's integration with Europe,² among others, it will hinder Georgia's progress towards EU membership, which does not have a similar law in any of its member states. At the same time, the implementation
